1 INTRODUCTION

The purpose of this ANNEX is to present the list of REVERSIBLE ASSETS that shall be reverted to the GOVERNMENT at the end of the CONTRACT.

2 ASSETS REVERSAL

REVERSIBLE ASSETS are all the essential assets and rights to continue the SERVICES related to the purpose of the CONCESSION, including, but not limited to:

- Items installed in the MUNICIPAL STREET LIGHTING NETWORK for the execution of STREET LIGHTING SERVICES, covering:
 - Exclusive STREET LIGHTING poles;
 - Components of STREET LIGHTING POINTS: luminaires, lamps, brackets with fixing hardware, relays, other equipment and components;
 - Control panels;
 - Exclusive transformers for STREET LIGHTING;
 - Exclusive Underground Passage Boxes for STREET LIGHTING;
 - Other equipment and components that make up the MUNICIPAL STREET LIGHTING NETWORK, including the exclusive underground and aerial network for STREET LIGHTING.
- Items installed in STREET LIGHTING points for the REMOTE MANAGEMENT SYSTEM:
 - REMOTE MANAGEMENT SYSTEM Control Devices;
 - REMOTE MANAGEMENT SYSTEM concentrators;
 - Supports;
 - Other equipment that integrate the REMOTE MANAGEMENT SYSTEM.
- Items of the STREET LIGHTING SERVICES OPERATIONAL CONTROL CENTER:

- Call Center - Service Desk: the full history of information recorded during the CONCESSION period, and the full backup infrastructure, in addition to the set of operational solutions related to applications, software, systems, etc... Software and systems necessary for the execution of the STREET LIGHTING SERVICES must be transferred by the CONCESSIONAIRE to the GRANTOR with licenses valid for a minimum period of 24 (twenty-four) months after the end of the CONCESSION, and covering all maintenance and warranty costs. As for the backup infrastructure used by the CONCESSIONAIRE, whether this is a solution related to storage on a remote server (cloud server) or another type of solution that requires payment of fees or licenses for use, the CONCESSIONAIRE must guarantee the use, by the GRANTOR.
- Network Operations Center – NOC: all information history, recorded during the CONCESSION period, and all backup infrastructure, in addition to all operational solutions related to applications, software, systems, etc... Software and systems that are necessary for the execution of the SERVICES must be transferred by the CONCESSIONAIRE to the GRANTOR with licenses valid for a minimum period of more than 24 (twenty-four) months after the end of the CONCESSION, and with coverage of all maintenance and warranty costs. As for the backup infrastructure used by the GRANTOR, whether this is a solution related to cloud storage or another type of solution that requires payment of fees or use licenses, the CONCESSIONAIRE must guarantee the use, by the GRANTOR, including all costs of maintenance.

REVERSIBLE ASSETS must be permanently inventoried and updated by the CONCESSIONAIRE, subject to approval by the GRANTOR.

The assets transferred to the CONCESSIONAIRE by the GRANTOR shall be mandatorily reverted to the GRANTOR.

The CONCESSIONAIRE may not retain or fail to return any of the REVERSIBLE ASSETS. The missing or damaged assets shall be indemnified by the CONCESSIONAIRE to the GRANTOR.

The civil infrastructure (real estate) built or acquired by the CONCESSIONAIRE, vehicles, tools and furniture (table, chairs, computers, etc.) are not considered REVERSIBLE ASSETS.
